## **STUDENT CONDUCT RULES AND REGULATIONS**

The following rules and regulations apply to all students participating in **B-Ball for Life Foundation, Inc. HBCU College Tour**.

1-Participants' behavior traveling should be such that it reflects positively on the organization, their home school and family at all times. This also applies to participants' conduct during social activities or times when no formal activities or meetings are scheduled, such as late evening and early morning hours.

2-Participants are expected to refrain from taking positions that are contrary or in conflict with the interest and/or positions of the group or detrimental to the group's event aims and purposes.

3-At all times, participants will show respect and courtesy toward others. Because sleeping and travel arrangements will often be shared, tolerance for individual differences and needs will be practiced.

4-Participants will dress appropriately for each situation (e.g. no excessively tight, revealing or clothing including jeans (ripped), T-shirts, sweats, etc. no clothing with explicit sexual content and/or the promotion of alcohol or drug use) and will adhere to any dress code asked of by the **agents of and chaperones designated by B-Ball for Life Foundation, Inc.**

6-Participants are expected to attend **ALL** meetings, workshops and other scheduled event programs. Students are expected to be prompt and prepared for all sessions.

7-Participants are to report any accidents injuries or illness to the agents of and chaperones designated by B-Ball for Life Foundation, Inc.

8-Alcoholic beverage consumption and or illegal drug use will not be tolerated. The use and/or possession of illegal drugs, handguns or weapons will not tolerated and will result in the student being **sent home immediately at the parent's/guardian's expense.**

10-Participants responsible for theft and/or vandalism during the course of the trip will be held financially liable and **sent home immediately at the parent's/guardian's expense.**

11-Any long-distance telephone calls, charges to the room or other personal expenses will be the **responsibility of the individual participant and/or parents/guardians.**

12-If a student needs to return home during a school function/trip for any reason, it is the students' responsibility for transportation and cost of such action.

13- The **agents of and chaperones designated by B-Ball for Life Foundation, Inc.** who are accompanying the group shall have total authority over the supervision of the event and its participants. This dictates that all student participants must adhere to and abide by the **agents of and chaperones designated by B-Ball for Life Foundation, Inc.** decisions and judgments and accord him/her the common courtesy and respect due by virtue of his/her position as the **agents of and chaperones designated by B-Ball for Life Foundation, Inc.**

13-Participants who disregard or violate these rules will be **sent home immediately at the parent's/guardian's expense.**
